

# Health, Safety and Environment (HSE) Policy

November 2022

## 1. Purpose & Scope

- 1.1. To establish, implement and maintain a Global HSE Policy.
- 1.2. HSE commitment and principles shall be clearly defined, communicated and visibly demonstrated by everyone.
- 1.3. The application of this policy is mandatory on all Nemak Sites and in connection with Nemak business off-site.

## 3. General Guidelines

### 3.1. Accountability

- a) The Executive Leadership team led by Nemak's Chief Executive Officer (CEO) shall establish the Global HSE Policy.
- b) The BU senior executive shall be active and visible in promoting a common understanding of Global HSE Policy, HSE expectations and HSE culture.
- c) The Site / Plant Manager responsible for HSE shall be accountable for implementing the Global HSE Policy.

### 3.2. Minimum Expectations

- a) The application of this Global HSE Policy shall be achieved through the implementation of the Global HSE Management System, which sets out Nemak's expectations and commitments to improving the HSE culture and performance.
- b) Management commitment and principles to execute World Class HSE standards shall be documented within the HSE Policy Statement (refer to Annex 1).
- c) A process shall be developed to ensure that the HSE Policy Statement signed by the CEO is at each BU location countersigned by the relevant BU Senior Executive and where appropriate, by the Site / Plant Manager responsible for HSE.

### 3.3. Maintaining Expectations

- a) A process shall be developed, within the HSE Global Community, to ensure that the HSE Policy Statement is reviewed annually and, where appropriate, updated and re-issued.
- b) The BU senior executive shall ensure that the budgeting process allows for sufficient resources (financial and manpower) to meet Nemak's HSE expectations and to implement, maintain and drive continual improvement of the HSE management system. This shall form part of the annual HSE program & budget review.

### 3.4. Communication and Engagement

- a) All Nemak employees shall receive training in the Global HSE Policy and its requirements.
- b) All Nemak contractors and visitors shall be made aware of the Global HSE Policy and its requirements.
- c) The signed HSE Policy Statement shall be prominently displayed at every Nemak location (see 3.2.c) for signature requirements).
